**AZ LOST BOYS CENTER, INC.  
VOLUNTEER AND EMPLOYEE NON DISCLOSURE  
AND NON COMPETITION AGREEMENT**

1. The undersigned is a volunteer or employee at AZ Lost Boys Center, Inc., an Arizona non-profit corporation. During the course of his/her volunteer work or employment (hereinafter "work"), undersigned has or will have access to information, process and ideas that are not generally known and that AZ Lost Boys Center, Inc. considers confidential. By way of example, AZ Lost Boys Center, Inc. considers the following to be confidential:

- a. Names, address, telephone numbers, email addresses and other personal information concerning AZ Lost Boys Center clients, their relatives and friends.
- b. Names, addresses, telephone numbers and email addresses for donors, potential donors, volunteers, supporters, employees and other persons that are or may be interested in AZ Lost Boys Center, Inc.
- c. Electronic data including computer program lists, source codes and object codes.
- d. All information relating to programs and policies now existing or currently under development by AZ Lost Boys Center, Inc.
- e. All documents or information concerning grants that AZ Lost Boys Center, Inc. has applied for or may apply for.

2. The undersigned is aware of the fact that the above list is intended to be illustrative and that other confidential information which the undersigned may have access to shall also be held confidential including such information that may exist or arise in the future. In the event that undersigned is not sure whether certain information is confidential, undersigned shall treat that information as confidential unless the undersigned is informed to the contrary in a writing signed by either (a) the Chairman of the Board of Directors or, (b) the Executive Director of AZ Lost Boys Center, Inc.

3. Undersigned agrees to surrender to AZ Lost Boys Center, Inc., all notes, records and documentation that were available used, created or controlled by undersigned during any work upon termination of his or her relationship with AZ Lost Boys Center, Inc. Also, subsequent to termination of work with AZ Lost Boys Center, Inc., employee agrees not to use any confidential information learned or obtained by the undersigned while associated with AZ Lost Boys Center, Inc.

4. If the undersigned violates any of his or her agreements to treat information confidential or if the undersigned violates the non-competition agreements contained in this contract, the remedies at law for AZ Lost Boys Center, Inc. shall be inadequate and, in addition to any other rights and remedies AZ Lost Boys Center may have, it shall be entitled to injunctive relief.

5. Should any court determine that any of the covenants in this agreement are unreasonable as to duration, scope or geographic areas, such covenants shall be reformed to the minimum extent required to be enforceable and, as so reformed, shall remain in full force and effect as provided herein with respect to such duration, scope and territory as a court of competent jurisdiction determines to be reasonable under applicable law.

6. Undersigned agrees to indemnify, defend and hold AZ Lost Boys Center, Inc. harmless against, and respect of all liabilities, losses, claims, costs or damages (including reasonable legal fees incurred in connection with any of the foregoing or in seeking enforcement of this agreement) resulting from or arising out of any failure by the undersigned to perform any of his or her obligations, covenants or agreements hereunder.

7. This Covenant shall be binding upon the inure to the benefit of the parties and their respective heirs, personal representatives, successors and assigns. This Covenant shall be governed by and construed in accordance with the laws of the State of Arizona.
